Discuss role we would like to play in the upcoming County Executive election (meeting with candidates, developing a platform, hosting a debate, etc)

There are currently 4 candidates. Primary scheduled for 8/18/24 and election on 11/5/24. Derr and Pulvermacher met with Agard. Exec. Board would like to interview candidates after the nomination paperwork submittal deadline. 6/19 at the Westport Town Hall was set as a tentative interview date. DCTA will host a candidate forum at the DCTA Membership Meeting on September 18th.

Update on request for working group to review Dane County Zoning code and conditional use permits

OA 68 regarding conditional use permit and rezoning processes that was requested by DCTA has been approved by 14 towns (no towns have voted in opposition). That OA is intended to provide immediate relief to towns that are having CUPs quickly resubmitted after denial in efforts to wear down opposition. The next step to address concerns is to set up a working group to discuss further zoning code changes. Lauber reported that County staff are good to set up the working group. Staff has informed Chair Doolan about the working group. Town members proposed are Cynthia Richson, Tom Mathies and Renee Lauber.

Legislative Report
